1- *A Taste of Spain* Tour Dates: September 12 – 23, 2022

September 12: Departure flight from US to Madrid, Spain

September 13: Arrive in Madrid and begin tour

September 23: Return flight to the US

UCE tours are **LAND ONLY**. Your flight plans should depart the US on Monday, September 12th to arrive no later than 9:00 am, Madrid local time, on Tuesday, September 13th ready to begin the tour. Your tour begins when you join the tour at the first hotel.

2- Tour Payment Deadlines: (See p. 5 for full details)

➤ 105 Days Before Tour Start Date: June 1st

The full price of the tour is due 106 days before the tour start date. If you are paying after the 106-day deadline, a 150€ Late Payment Fee will be charged.

➤ 104 to 74 Days Before Tour Start Date: July 1st (last day to register)

Anyone who wishes to enroll between 74 to 104 days prior to the tour start date **MUST** request to enroll in **WRITING BY EMAIL**. *Late registration is accepted based on availability.*

Transportation:

1- Airport transfers: Transportation to and from the US, and to and from airport on arrival and departure days is not included. Taxi to/from airport to city center is a flat rate of 30€ per taxi. **Credit card payment is available in all Madrid taxis.**

2- International flight information Participants are responsible for purchasing and making their own flight arrangements from country of origin to Barajas Airport, Madrid

Health Information:

1- Covid-19 mask use

In Spain, masks are required on all flights, trains, taxis, and public transportation as well as in pharmacies, hospitals clinics, doctor's offices, and nursing homes. Covid-19 mask regulations are subject to change. You must comply with all local regulations. During the tour, your UCE Tour Directors will enforce the recommended guidelines outlined by the European Union as well as any local restrictions of the cities and/or countries you will visit during the tour.

2- Negative Covid Test return to US

ALL passengers entering the US are required to show proof of a negative Covid Test. For your convenience, UCE will make appointments for the test within the last 48 hours of your trip. Testing expenses are payable by the individual travelers.

3- Travel fitness

All UCE participants must be in good physical condition to travel. UCE's tour requires daily walking as the primary means of transportation, walking long distances - especially on city walking tours, climbing stairs, and carrying one's own luggage, as portage is neither included nor available. Participants should anticipate natural and architectural conditions which are beyond UCE's control. Special meals and medical supervision/assistance cannot be provided during the tour.
